

Total revenues increase by 17.5 % . Amount to be raised by taxes increases 4.3%.

Utilization of Fund Balance increases by \$1,301,030 due to increased voter approved capital projects. Interest income will decrease \$25,000 due to a lower projected cash balance in 2021. Fringe Benefits will increase an overall \$251,558 due to increased payroll taxes, pension expense, and health insurance costs. Miscellaneous expenses increase \$93,221 primarily due to increased maintenance expense \$48,000 related to aquired real estate, which is offset by a budgeted decrease in rent of \$25,000. The District will also budget an additional \$6,800 in furniture expense, again due to real estate acquisitions, as well as budgeting an increase of \$10,000 in contingency costs. Vehicle Expense- Lease will increase \$18,000 due to the addition of two new short term vehicle leases.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The Amount to be Rased by Taxation increases \$ 354,920. The District will utilize \$2,092,664 in unrestricted fund balance . This will not have any impct on the 2022 budget.




