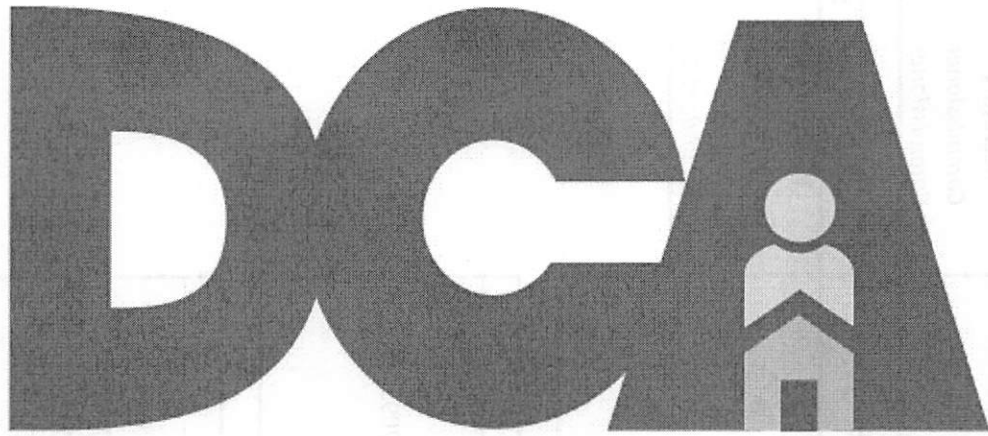

WHEREAS, the Annual Budget for Woodbridge Township FD No. 1 (the 'Fire District') for the fiscal year beginning January 1, 2023 and ending December 31, 2023 has been presented before the Board of Commissioners of the Fire District at its open public meeting of December 14, 2022; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$17,077,310.00 which includes an amount to be raised by taxation of \$15,288,244.00 and Total Appropriations of \$17,077,310.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on December 14, 2022 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2023 and ending December 31, 2023 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

BE IT FURTHER RESOLVED, that the Board of Commissioners of the Fire District will consider the Annual Budget for adoption on January 17, 2023.

WHEREAS, the Annual Budget for the Woodbridge Township FD No. 1 (the 'Fire District') for the fiscal year beginning January 1, 2023 and ending December 31, 2023 has been presented for adoption before the Board of Commissioners of the Fire District at its open public meeting of January 17, 2023; and

WHEREAS, the Annual Budget as presented for adoption reflects each item of revenue and appropriation in the same amount and title as set forth in the introduced and approved budget, including all amendments thereto, if any, which have been approved by the Director of the Division of Local Government Services; and

WHEREAS, the adopted budget includes a proposed public referendum in the amount of \$3,435,000.00 in excess of the allowable amount to be raised by taxation; and

WHEREAS, the Annual Budget as presented for adoption reflects Total Revenues of \$17,077,310.00 which includes amount to be raised by taxation of \$15,288,244.00, and Total Appropriations of \$17,077,310.00; and

WHEREAS, an election shall be held annually on the third Saturday of February in each established fire district to determine the amount to be raised by taxation for the ensuing year;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District at an open public meeting held on January 17, 2023 that the Annual Budget of the Fire District for the fiscal year beginning January 1, 2023 and ending December 31, 2023 is hereby adopted and, shall constitute appropriations for the purposes stated and authorization of Total Revenues of \$17,077,310.00, which includes amount to be raised by taxation of \$15,288,244.00, and Total Appropriations of \$17,077,310.00; and

Total Appropriations are budgeted to increase \$6,298,312 largely due to increases for New Firefighter Salaries, Health Benefits, Fringe Benefits, Uniforms, Turnout Gear & Radios. The Voters of the District are being asked to approve a referendum authorizing \$3,435,000 for these additional expenses. The District is also budgeting to spend \$2,200,000 in Capital Projects approved by the voters of the District in 2022.

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Interest Income decrease \$5,000 due to less investable funds on hand in 2023. Uniform Safety Act revenues decrease \$47,263 due to decreased fines due to better compliance. Administrative Salaries and Wages increase \$45,411 due to increased responsibilities taken on by the Administrative Secretary regarding increased personnel and capital projects commencing in 2023 which requires an increase in salary of \$24,611, as well as the hiring of an intern at a cost of \$20,800. Administrative Fringe Benefits increase because of increased salary costs. Operations & Maintenance Salaries and Wages will increase \$3,876,479 primarily as a result of the proposed referendum on hiring more firefighters. Operations benefits increase \$542,012 due to the hiring of 11 additional firefighters. The District also entered into a new interlocal substation agreement to operate a substation in the District, at a cost of \$50,400. Fire Prevention Revenues are expected to decrease primarily due to less fine being collected due to less offenders of existing fire codes within the District. Professional services are budgeted to decrease \$27,000 due to less need for outside legal counsel in 2023.

The 2023 budget will increase the Amount to be Raised by Taxation by \$6,411,840 provided the District voters approve the proposed Referendum. The District will be utilizing \$1,678,031 in available Fund Balance. This will not have an impact on the 2024 budget.
